EASY GUIDE TO SELLING YOUR SHARES

How do I know what value I will get for the shares I sell?

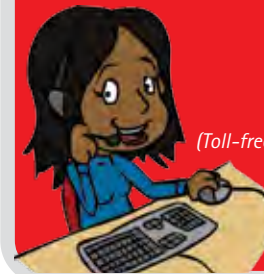
SO ... first work out how many shares you want to sell ... then at what price per share ... then minus the transaction cost.

If the amount is less than what you want, you can increase the price per share that you want to sell it at.



But remember: depending on your TAX profile, you might have to pay SARS tax

HOW LONG BEFORE I RECEIVE PAYMENT

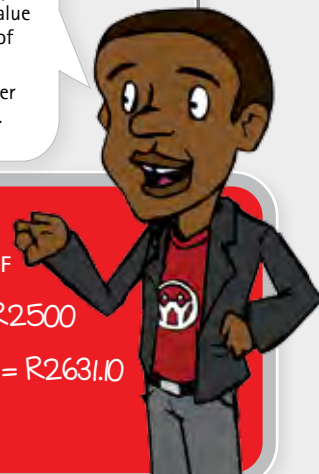
Trading day plus 3 working days

If your trade is matched on Thursday you will receive payment in your bank by the following Tuesday

If you use the preferred stockbroker there is a fee of R115 plus VAT up to R40 000 of shares and on the value above R40 000 there is a fee of 0.35% plus VAT.

If you use your own stockbroker these costs may be different.



SO YOU HAVE PLACED A SELL OFFER OF

50 shares x R50 a share = R2500

Plus R15 plus 14% VAT (R16.10) = R2631.10

Once your offer has been matched with a buyer you will receive

$R2500 - R15 \text{ plus } 14\% \text{ VAT} = R2368.90$

This money will be deposited into your trading account and on your instruction

- You can transfer some of it to your personal bank account and keep some in your trading account
- Or you can transfer the full amount to your personal bank account

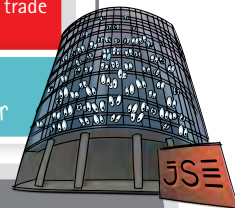

SO WHAT COSTS MUST I CONSIDER BEFORE BUYING?

The total amount must then be deposited into your trading account **BEFORE** you can place your buy-bid for the 300 shares.

Deposits can either be cash deposits or EFT. An SMS confirmation will be sent to you.

You are now ready to trade and can do so by visiting:

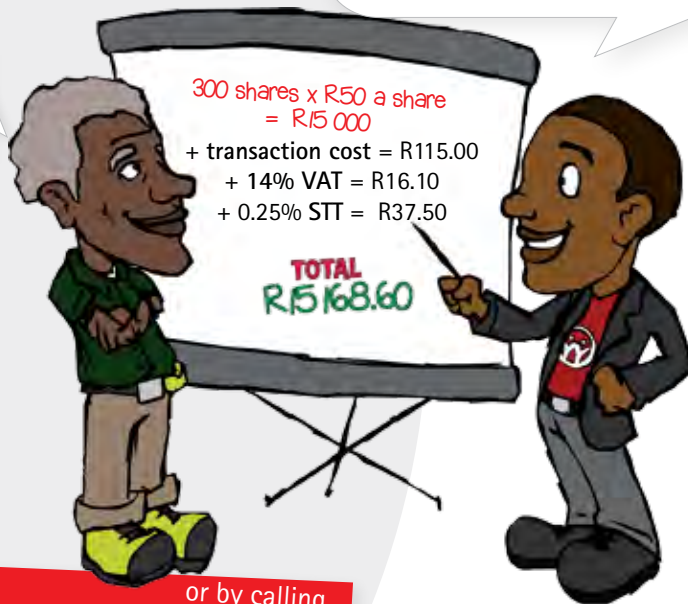
If you wish to buy 300 shares at R50 per share you will need to pay:

300 shares x R50 a share
= R15 000
+ transaction cost = R115.00
+ 14% VAT = R16.10
+ 0.25% STT = R37.50
TOTAL R15 168.60

If you use the preferred broker and the buying value is less than R40 000

There is a transaction cost of R115 plus 14% VAT

Then there is a statutory tax called a Security Transfer Tax (STT) which is levied on every transfer of a security 0.25% of total value
